The Westmont Police Department has received your request for information. The information you requested was on incident #01-10-1880. Your request has been denied in part. I have released you the information that was not denied by redacting information in the report.

On #01-10-1880 there were no arrests made. Information was partially denied. There was no disclosure of information protected under section 7(1)(d)(iv) as disclosure could unavoidably identify a person filing a complaint or providing information. Only the disposition of the incident is being released under the Freedom of Information Act Section 7 (1)(d)(vii) as the case is still under investigation and disclosure could obstruct the ongoing criminal investigation.

In the event of a record request denial the requestor has the right, under the Illinois Freedom Act, to appeal their request. The first appeal of this request must be made in writing directly to the Public Access Counselor of the Illinois Attorney General's Office. The Office of the Public Access Counselor will be housed within the Illinois Attorney General's Office at 500 S Second Street, Springfield, Illinois 62705. The Public Access Counselor's decision is reviewable under the Illinois Administrative Review Law.
